In 2013 the Museum's Finance Committee (Baty, Belanger, Green, Wolf, Sterling) developed an investment policy (approved by the Board at its May 2013 meeting) and issued an RFP for a financial consulting firm to manage the Museum's investments so as to improve the return from those investments. Board member David Wolf works for a financial firm, Widmann Financial, and asked whether his firm might submit a proposal. Mr. Wolf explained that he has nothing to do with investments made at the firm and if selected another individual would be managing the account. He also agreed to recuse himself from the selection process. Five firms responded and the three judged most responsive were invited to meet with the selection committee (Medallion Financial, UBS, and Widmann Financial) After studying the material submitted and listening to the presentations, the committee (sans Wolf) unanimously recommended to the Board that Widmann Financial be hired to manage the Museum's investment portfolio.

Tube Radio Repair Classes:
